# Ordinary Meeting of Madron Parish Council held at Landithy Hall on Wednesday 04<sup>th</sup> June 2025, at 7.30pm

- 1. Apologies Were received from Cllr C Whitton and Cllr Richard Mann. Cllr Cudmore was absent.
- 2. Acceptance of Minutes The minutes of the annual council meeting held on the 15<sup>th</sup> May 2025 were unanimously agreed.
- 3. Declarations of interest in items on this agenda None.
- 4. Dispensations none received.
- **5. Register of Interest forms** –register of interests forms and acceptance of office forms were received from Cllrs England, Roberts, Scoble and Clackworthy.
- **6.** Public Participation none.
  - It was RESOLVED to move co-option up the agenda to item 7.
- **7. Co-Option** Applications have been received from Melville Thomson and Madeliene Nicholls and circulated to members. Both applicants spoke about their interest in community life and willingness to give something back to the community and improve the parish for everyone.
  - It was REOSLVED all in favour that both applicants were co-opted into the two vacant seats.
- 8. Chairmans Comments Cllr Eddy reminded Cllrs that if they are unable to attend a meeting to let the clerk know. The two new bin lids have been installed. Parking at Badgers Cross junction appears to be a cumulation of garage and resident cars. Cllr Eddy will visit over the next month to see what can be achieved to make the junction safer and less congested for large vehicles.
  - There is Japanese knotweed in the allotments, Cllr J Line agreed to raise with CC.
- 9. Councillor's Questions and Comments (24 hour's notice to clerk advisable)
  - Councillor attendance figures for 2024/2025 are on the website.

The King William public house is having new gas pipes installed. This will result in the new road surface being dug up. Clerk to contact highways to ensure that it is replaced in such a way that the warranty is not affected.

Badgers Cross parking congestion videos have been sent to the clerk.

Newmill parking photos have been circulated and sent to the police. The police response was not very helpful. It was agreed that the clerk would send all emails to Cllr Line to arrange a site meeting with the police / highways.
